## Information about Voting and Important Deadlines

- **Eligible citizens can register to vote online:** [Register to Vote In Florida](#)
- **Domestic voters begin to receive mail-in ballots:**  
September 26 - October 3
- **Voter registration deadline:** October 7
- **Deadline for domestic voters to request a mail-in ballot:** October 24
- **Early Voting Period:** October 26 - November 2
- **Federally recommended guidance for voters submitting mail-in ballots:**  
At least one week before election day (October 29)
- **Deadline for domestic voters to submit a mail-in ballot:** November 5
- **Election Day:** November 5
- **Find your voter information (sample ballots, voting precinct, request ballots):**

- When voting at any voting location, whether at an early voting site or on Election Day, a current and valid identification with your name, photograph and signature is required. Here is a [list of acceptable forms](#) of identification that voters can use.
- **Note:** Additionally, While a voter information card is not required to vote, it can help expedite the voting process. If you lack a proper ID, you may have to vote on a provisional ballot.

# GENERAL ELECTION VOTING INFORMATION

- **Please review the entire ballot before submitting.** The Ballot Amendments may be the last items to appear on your ballot.
- If you registered to vote recently and you find that your name is not in the registration book, do not leave. First, ask an elections poll worker if there is a supplemental registration list. Second, ask the election worker to call the Miami-Dade County Elections office and issue you a provisional ballot.

# PROPOSED STATE CONSTITUTIONAL AMENDMENTS

## [Amendment 1: Partisan Election of District School Boards](#)

**Description:** Proposing amendments to the State Constitution to require members of a district school board to be elected in a partisan election rather than a nonpartisan election and to specify that the amendment only applies to elections held on or after the November 2026 general election. However, partisan primary elections may occur before the 2026 general election for purposes of nominating political party candidates to that office for placement on the 2026 general election ballot.

## [Amendment 2: Right to Fish and Hunt](#)

**Description:** Proposing an amendment to the State Constitution to preserve forever fishing and hunting, including by the use of traditional methods, as a public right and preferred means of responsibly managing and controlling fish and wildlife. Specifies that the amendment does not limit the authority granted to the Fish and Wildlife Conservation Commission under Section of Article IV of the State Constitution.

## [Amendment 3 \(22-05\): Adult Personal Use of Marijuana](#)

**Description:** Allows adults 21 years or older to possess, purchase, or use marijuana products and marijuana accessories for non-medical personal consumption by smoking, ingestion, or otherwise; allows Medical Marijuana Treatment Centers, and other state licensed entities, to acquire, cultivate, process, manufacture, sell, and distribute such products and accessories. Applies to Florida law; does not change, or immunize violations of, federal law. Establishes possession limits for personal use. Allows consistent legislation. Defines terms. Provides effective date.

## [Amendment 4 \(23-07\): Limit Government Interference with Abortion](#)

**Description:** No law shall prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as determined by the patient's healthcare provider. This amendment does not change the Legislature's constitutional authority to require notification to a parent or guardian before a minor has an abortion.

# PROPOSED STATE CONSTITUTIONAL AMENDMENTS

## [Amendment 5: Adjustments to the Value of Certain Homestead Exemptions](#)

**Description:** Proposing an amendment to the State Constitution to require an annual adjustment for inflation to the value of current or future homestead exemptions that apply solely to levies other than school district levies and for which every person who has legal or equitable title to real estate and maintains thereon the permanent residence of the owner, or another person legally or naturally dependent upon the owner is eligible. This amendment takes effect January 1, 2025.

## [Amendment 6: Repeal of Public Campaign Financing Requirement](#)

**Description:** Proposing the repeal of the provision in the State Constitution which requires public financing for campaigns of candidates for elective statewide office who agree to campaign spending limits.
